After serving on the Board of Living Edge for several years in its inception, I was persuaded to return as the Chair when Rev. Dr. Rod Ellis stepped down. It's been a pleasure this past year– we have a great team of directors and administration workers.

2019 was a year of huge changes with the closure of the dinners at Quadra. Change is never easy. We had to maneuver this carefully as everyone involved in these dinners loved being there as volunteers. They built a strong sense of community and many had come to know the regulars. The gospel was preached, good food served, conversations between volunteers and recipients were invaluable.

However, through circumstance beyond our control, the dinners were no longer viable. Costs were rising, the building was deteriorating, and children's ministry had stopped. Neil made a huge effort to find an alternate location, but to no avail. It was clear, the time had come for changes. There has been dep concern expressed to us that with the closure of the dinners, the Gospel portion has stopped. That the Evangelical outreach has ended. Nothing could be further from the truth!

Living Edge had already started food distribution through Neighbourhood Markets manned by various churches and organizations throughout the city. We now have 10 locations - Quadra Village, Gateway Baptists, UVic Family Centre, Central Baptist, Saanich Baptist, Open Gate Church, First Baptist, Emmanuel Baptist, Harbourview Church and University Christian Ministry. The decision was made to concentrate on growing the effectiveness of these 10. Now we reach hundreds of people every single week through these host sites working together with LE. What a testimony!

We had a very successful Strategic Planning Day in order to prioritize the way forward. Out of this one of the priorities is to make opportunities for the leaders and other volunteers from each center to come together. to meet one another, to hear testimonies and to share ideas.

As a result, we recently hosted a luncheon, bringing leaders from each location together. We heard amazing testimonies of a myriad of opportunities to share the Gospel on site. Having been a part of this ministry from the beginning, I personally was deeply moved to hear the stories. Truly, through the distribution centres, at each of the Neighbourhood Markets the Gospel is being seen and heard. We have much to celebrate!

We give thanks for all who continue to support this ministry, for the food provided, for churches and organizations working together throughout the city, for those who give financially, for those who pray, for the Living Edge staff and so on.

May Living Edge continue to flourish on into the future - to the Glory of God!

FINANCIAL REPORT

A. 2019 Operating results compared to budget The revenue for Living Edge received in the general fund in 2019 was \$189,210. As with the previous years we were blessed by significant support from Church of Our Lord (\$46,062); partner churches and organizations in Greater Victoria including Gateway Baptist Church, Harbourview Community Church, The Open Gate Church, Central Baptist Church, Emmanuel Baptist Church, Friendship Community Church, Saanich Baptist Fellowship, Saanichton Bible Fellowship, Connection Life Centre, West Village Church, Shelbourne St Church of Christ and University Christian Ministries (\$41,470); offerings from our faithful supporters (\$63,691); Victoria Foundation (\$15,000); the City of Victoria (\$10,000); the Anglican Network in Canada (\$500).

There was only one fund raising event in the year – Ride for Refuge which raised \$2,759. Three performances by the Soul Source Community R&B Band raised \$3600. The total revenue was below the budget by \$60,090. This significant shortfall was due to reduction in income from various sources and the lack of significant fundraising activities.

Expenses of \$189,034 were \$60,266 below budget. This reduction, which was comparable to the reduction in revenue presented above, may be partly attributable to the decreases in expenses as a result of the dis-continuation of the Sunday Dinners during the past year. Apart from an increase in expenses for ministry workers for distribution, all other expenses were within budget, reflecting the change in focus to more food distribution. We ended the year with a net income of \$175.

The current Thrifty Foods Smile Card program, which is earmarked for a replacement van for the food distribution program, had a balance of \$6,874.58 at the end of the year.

B. 2020 budget

Due to the need to confirm a few more facts and assumptions before finalizing the 2020 budget, the budget will be presented at the meeting.

C. Balance Sheet and Cash Flow

On December 31, 2019, Living Edge had assets of \$14,669.74 in our Society's name at Vancity and the remainder in our general account.

A HUGE heartfelt thank you to our many volunteers who are the heart and soul of Living Edge. Your passion and generosity make it happen. Without your devotion and generous sharing of your time, we would not be able to help so many people.



Living Edge was very blessed in 2019 by the generosity of sustainable donors like the Victoria Foundation, Edward Jones Foundation, ANiC, Church of Our Lord, Neighbourhood Market hosts, and financial supporters who provided funding for our neighbourhood market program. When we reached out to the community and announced we needed a newer van Lutheran Church of The Good Shepherd donated a 12 seater van that, with a few adjustments, was perfect for us.

Our Director of Finance has presented us with a realistic and lean budget for 2020 that includes historical expenses and proven donor revenues. We have applied for \$15,000 from the Victoria Foundation and \$10,000 from the City of Victoria. It will not be known until June 2020 if we were successful with either grant.

We are relying on support from our generous donors and our market programs to generate funds to cover market expenses in 2020. Our \$20/month campaign generated more monthly donors than in previous years. This type of giving provides us with sustainable revenue throughout the year money that our Director of Finance can count on being there for us every month. We will be working on improving the success of this campaign.

To enhance our fundraising we have to become more creative and pro-active with our fundraising plan. To accommodate and ignite growth, Living Edge needs to plan a formalized program, collaborate internally and use a digital platform to help raise funds both online and off. We have to explore new ways of generating revenue - perhaps through additional sponsorships at each market. Our ten neighbourhood markets have become very popular with the hosting communities and are helping so many people living in the CRD who are food-deprived and is a proven and very attractive program for sponsors to be part of.

We still need a proven donor data program to track giving both from individuals, corporations and grants. Unfortunately, it is not in the budget for 2020 but will be on the 'wish list' for 2021.

In 2020, the organization is focusing on bare-bones expenditures and more sustainable funding throughout the year. Thank you to our generous donors in 2019 – we could not offer food to over 5,000 families and individuals each month without their support.

Neighbourhood Markets



We added a market in Esquimalt to our list of Neighbourhood Markets in 2019. That brings our total to ten Living Edge markets throughout Greater Victoria. Hundreds of volunteers cheerfully and faithfully serve hundreds of people each week, thousands of people each month, and well over 60,000 souls each year. Our real impact cannot even be measured as many clients share with their friends and neighbours, or take food to other needy folks in their community. Many new clients are brought to tears by this provision; they cannot believe that there is no registration or identification required, and that there are truly 'no strings attached'. This enables even those with short-term needs to make ends meet without being deprived of a basic human right; fresh food! Everyone involved is blessed! Many clients are so appreciative that they want to volunteer with us to 'pay forward' the blessings they have received. To this end, we have found many ways to engage the extra help: set up and take down tents and tables; prepare the coffee station; sort produce; handout the groceries; handout the numbers; call the numbers; or serve cake or pastries to the folks in the waiting areas.

One market has a volunteer take plastic bags home, roll them open, and then bring them back, ready to fill!

Our profile on social media has increased by over 45% this year. We now have almost 1300 followers on Facebook! More followers equates to more clients, more support, and more opportunity to help those in need with the daily abundance of groceries from our generous donors.

Each market is creative in the way it meets the needs of its local neighbourhood: some markets have activities for children while they wait; others have a more elderly clientele and offer space to chat and enjoy a cup of tea or coffee while waiting; still others have volunteers circulate amongst the clients simply to engage in conversation. Even though each market has its own unique 'flavour', some things are universal; relationships are forming, trust is building, people are encouraged; and hope grows!
